Terms and Conditions.

Welcome to the Derby Memorial Swimming Pool, A Shire of Derby/ West Kimberley operated facility. The Derby Memorial Swimming pool opened in 1958 and is dedicated as a memorial to the service personnel from derby who volunteered during World War I and World War II.

The facility includes a 6 lane 25m outdoor pool, toddler pool, playground and a splash park.

Membership cards

Membership cards must be shown to staff to gain entry. Staff may request at any time that you provide your membership card for identification.

Membership Suspension and Suspension Period Limits:

Memberships can be suspended according to the suspension period limits. The suspension period limits do not apply if your suspension is due to physical illness or injury which prevents participation at the facility, in which case a medical certificate is required. All suspensions must be submitted in writing and must state the reason of suspension.

Refunds or Credits

All memberships are non-refundable and are unable to be credited. However we are able to transfer to a third party. Application to transfer must be received in writing.

Conduct

Management reserves the right to suspend or expel any member for failing to comply with the Aquatic area Conditions of Entry or for conduct that management deems improper. All members use the facility at their own risk. Please report any inappropriate behaviour by other users to staff immediately.

Smoking, Drinking and Eating

SMOKING and/ or THE CONSUMPTION OF ALCOHOL IS STRICTLY PROHIBITED anywhere within the facility including toilets. Person under the influence of alcohol or drugs are not permitted within the facility. No glass containers are permitted within the facility and no eating in any of the pools or Splash Park.

Age Restrictions and Supervision

Children under the age of 5 years must be within arm's reach of a parent or competent guardian that is 16 years or older and children under the age of 10 years must be actively supervised by an adult or competent guardian that is 16 years or older at all times when in the facility.

Dress Code

Appropriate swimwear is to be worn at all times in the pools. No cut-off jeans or nudity. Toddlers MUST wear swim nappies when in the pool.
