Mr Chris Travers – Sutherland Street Improvement Works

I have previously raised on numerous occasions the condition of Sutherland Street and the lack of footpaths on this street. In 2010 I received correspondence stating that it will be resealed and footpaths installed.

What is the progress on these works?

Mr Wayne Neate – Director Technical and Development Services

The reconstruction of Sutherland Street is an expensive project and to enable Council to afford the works it will be done over two financial years. There is an allowance of \$450,000 in the current 2017/2018 budget to commence these works with the project rolling in to the 2018/2019 financial year with a projected allocation in that year of \$550,000 to complete the works.

Tenders will be advertised in the coming months for this project which included reconstruction of the entire street and the installation of a footpath.
