Notes for Elected Members

NATURE OF COUNCIL'S ROLE IN DECISION MAKING

Advocacy: When Council advocates on its own behalf or on behalf of its

community to another level of government/body/agency.

Executive/Strategic: The substantial direction setting and oversight role of the Council

such as adopting plans and reports, accepting tenders, directing

operations, grants, and setting and amending budgets.

Legislative: Includes adopting local laws, town planning schemes and policies.

Administrative: When Council administers legislation and applies the legislative

regime to factual situations and circumstances that affect the rights of people. Examples include town planning applications, building licences and other decisions that may be appealable to the State

Administrative Tribunal.

Review: When Council reviews a decision made by Officers.

Information: Includes items provided to Council for information purposed only

that do not require a decision of Council (that is for 'noting').

ALTERNATIVE MOTIONS

Councillors wishing to make alternative motions to officer recommendations are requested to provide notice of such motions in written form to the Director Corporate and Community Services prior to the Council meeting.

DECLARATIONS OF INTERESTS

Elected Members should fill in Disclosure of Interest forms for items in which they have a financial, proximity or impartiality interest and forward these to the Presiding Member before the meeting commences. Section 5.60A of the *Local Government Act 1995 states*;

"a person has a financial interest in a matter if it is reasonable to expect that the matter will, if dealt with by the local government, or an employee or committee of the local government or member of the council of the local government, in a particular way, result in a financial gain, loss, benefit or detriment for the person."

Section 5.60B states;

"a person has a proximity interest in a matter if the matter concerns –

- (a) a proposed change to a planning scheme affecting land that adjoins the person's land;or
- (b) a proposed change to the zoning or use of land that adjoins the person's land; or
- (c) a proposed development (as defined in section 5.63(5)) of land that adjoins the person's land."

Regulation 34C (Impartiality) states;

"interest means an interest that could, or could reasonably be perceived to, adversely affect the impartiality of the person having the interest and includes an interest arising from kinship, friendship or membership of an association."

APPLICATION FOR LEAVE OF ABSENCE

In accordance with Section 2.25 of the *Local Government Act 1995*, an application for leave requires a Council resolution granting leave requested. Council may grant approval for Leave of Absence for an Elected Member for ordinary Council meetings for up to but not more than six consecutive meetings. The approval of the Minister is required for leave of absence greater than six ordinary Council meetings.

This approval must be by Council resolution and differs from the situation where an Elected Member records their apologies for the meeting. A failure to observe the requirements of the Act that relates to absence from meetings can lead to an Elected Member being disqualified should they be absent without leave for three consecutive meetings.

2 ATTENDANCE VIA TELEPHONE/INSTANTANEOUS COMMUNICATIONS

In accordance with regulation 14A of the Local Government (Administration) Regulations 1996 Council must approve (by Absolute Majority) the attendance of a person, not physically present at a meeting of Council, by audio contact. 6.1 TENDER T2019-01 - FITZROY CROSSING ROADS RECONSTRUCTION

SUMMARY

This item is to consider the award of a tender for the reconstruction of Forrest Rd, Geikie Gorge Rd and the intersection of Geikie Gorge and Russ Roads.

DISCLOSURE OF ANY INTEREST

Nil.

BACKGROUND

Funding was allocated in the 2018/19 Budget for the reconstruction of the following sections of roads in Fitzroy Crossing:

- The rutting on the west side of Forrest Rd between Fallon and Scrivener Rd;
- The road pavement on Geikie Gorge Rd around the turnoff to Brooking Springs Station; and
- The realignment of the intersection of Geikie Gorge and Russ Roads to a T-Intersection.

It has been recognised by Councillors and Staff for some time that sections of Forrest Rd and Geikie Gorge Rd are in a poor condition. The roads have deteriorated to a point where a reseal will be of minimal benefit so a full reconstruction is the only option available to increase the life of the road pavement.

The intersection of Geikie Gorge and Russ Roads was identified as a Black Spot risk for collisions during a Road Safety Audit. A new T-Intersection was designed to comply with Main Roads WA standards and eliminate the likelihood of sideswipe collisions.

FINANCIAL IMPLICATIONS

Funds for the undertaking of this contract are contained within the adopted 2018/19 Budget as follows:

- Forrest Rd Reconstruction (\$241,615 Main Roads WA Road Project Grant, \$120,808 from the roads portion of the Federal Assistance Grants (FAGS)).
- Geikie Gorge Reconstruction \$190,800 Direct Grant)
- Geikie Gorge/Russ Rd Blackspot intersection upgrade (\$173,690 State Black Spot, \$86,845 FAGS).
- A Nomination has been submitted to Main Roads WA to reallocate surplus funds from Knowsley St West Reconstruction Stage 2 to Geikie Gorge Rd Reconstruction to allow the full scope of the latter project to be completed.

These budget amounts include a management overhead cost associated with the job.

CONSULTATION

The tender was advertised state wide for a minimum of 14 days with submissions closing at 2:00pm, 2 April 2019. Documents were downloaded by 17 companies. The only submissions received were a Conforming and Alternative Tender submitted by Buckley's Earthworks and Paving.

COMMENT

The lack of responses to this tender can be partially attributed to the requirement to complete these works prior to 30 June 2019. Also, a large volume of construction (Cape Leveque Rd, Chinatown in Broome) and reconstruction (local government and Main Roads WA flood damage) works are currently underway throughout the Kimberley.

Buckley's Alternative tender submission includes the addition of cement stabilisation to the basecourse material for both Forrest Rd and Geikie Gorge Rd reconstruction projects. This option is a practicable alternative that will prolong the life of the pavement.

A nomination has been submitted to Main Roads WA to reallocate funding from Knowsley St West Reconstruction Stage 2 to Geikie Gorge Rd Reconstruction to cover the costs exceeding the approved budget.

It has been recognised by Councillors and Staff for some time that Knowsley St West is in a poor condition. The road has deteriorated to a point where a reseal will be of minimal benefit so a full reconstruction is the only option available to increase the life of the road pavement.
