**December 2016 : Information Update 5 – Public Environmental Review** 

## PUBLIC ENVIRONMENTAL REVIEW

The Environmental Protection Authority (EPA) has set the level of assessment for the Thunderbird mineral sands proposal as Public Environmental Review (PER). The project is a "Controlled Action" under the Commonwealth EPBC Act and will be assessed under the Bilateral Agreement between the Commonwealth and Western Australia.

The Thunderbird PER has been prepared by Sheffield to examine the environmental effects associated with the proposed Thunderbird mineral sands development. The PER describes the proposal, examines the likely environmental effects and proposes environmental management procedures.

Sheffield has submitted the draft Thunderbird PER to the OEPA (Office of the Environmental Protection Authority), the administrative arm of the EPA and is anticipating release of the document for public review.

### THUNDERBIRD PROJECT

The Thunderbird Mineral Sands Project, located between Broome and Derby, is being developed by Western Australian company Sheffield Resources Limited.

Thunderbird is a large-scale, mineral sands mining and processing project with low environmental impacts and long term economic and community benefits.

Sheffield is undertaking a Bankable Feasibility Study and Public Environmental Review (PER) of Thunderbird, scheduled for completion in 2017. Start of construction is planned to follow immediately thereafter with first exports through the ports of Derby/Broome targeted for 2019.

Sheffield believes that Thunderbird can help transform the community through the creation of 140 permanent and many indirect local jobs. Income would stay in the region supporting families, business, cultural values and lifestyle.
